














As a part of the Swachhata Pakhwada observed across Jharkhand from 29th April to 15th May 2023, a variety of cleaning and solid and liquid waste management activities were organized in Sahibganj district, the only district in Jharkhand which is a part of the Namami Gange programme.

There are 78 villages bordering the Gange River in the Sahibganj District of Jharkhand. During the state-level campaign, the district administration of Sahibganj organized various activities to promote cleanliness along the river and its banks and prevent pollution.

Among the IEC activities were; Swachhata rallies, essay writing, drawing and quiz competitions; Ganga aarti, slogan writing, administering of the swachhata oath; and plantation of saplings. A large number of students from various schools and institutions participated in the activities and took the swachhata oath in support of the

campaign. Moreover, various departments extended support to the campaign that saw a Ganga Aarti each evening.

On the heels of last year's successful sanitation campaign, Tamil Nadu has once again launched the Namma Ooru Superu (Our village is the best) campaign with a view to ensuring safe sanitation practices and cleanliness in rural areas across the state. The campaign is being held from 1st May to 15th June 2023.

This year's campaign is intended to strengthen the State's progress toward ensuring environmentally sustainable and clean villages. Further, emphasis will be given to the effective management of legacy waste, and achieving the State's retrofitting target. It will also include health and welfare measures for workers undertaking sanitation-related works.

While the districts have formed village-level committees to oversee the campaign, the state has called upon all Departments to support the campaign and ensure its success. Among the

activities that will be implemented are: Mass cleaning of public institutions/places; Awareness in schools and colleges on water, sanitation, and waste management; Awareness of water, sanitation, and waste management at households and institutions through Self Help Group (SHG) Members; Ban on Single Use Plastics (SUP) and use of alternatives; and Plantations and other cleaning activities that would make villages clean and green.

OSSS WASH Mitras ensure timely repair & maintenance of WASH facilities

In a move to ensure the sustainability of ODF Plus assets, Maharashtra's 'One-Stop Shop and Services (OSSS) WASH Mitra' initiative offers comprehensive skill training to young people in the areas of WASH facility repair and maintenance.

Sanitation and hygiene in schools are essential for enhancing student learning, reducing dropout rates - particularly among girl students, improving children's health, and preventing disease. However, an educational institution lacking inadequate water, sanitation, and hygiene (WASH) facilities and having faulty electrical fittings, broken furniture, blocked drains, and leaking pipes, in addition to poor operation and maintenance of available facilities, cannot fulfil its goals adequately.

To find a solution for the upkeep of WASH infrastructure in schools, Pratham Education Foundation (PEF), Centre for Youth Development and Activities (CYDA) and UNICEF Maharashtra

came together to launch the One-Stop Shop and Services (OSSS) WASH Mitra initiative to address the operation and maintenance demand cum services crises in Government Schools through Young WASH Entrepreneurs (YWEs) as Service Providers in schools/institutions and Gram Panchayats in 14 districts of Maharashtra.

OSSS WASH Mitra helps to keep WASH facilities in schools functional, enabling students to stay in schools, build hygiene habits for life and stay healthy. In doing so, the OSSS initiative also aims to support the Swachh Bharat Mission (Grameen) and the Jal Jeevan Mission by building cadres of youth who can help improve and enhance the WASH services and the ongoing efforts aimed at improving hygiene and upkeep of facilities.

FSTP in Benipur services 11 GPs

A Faecal Sludge Treatment Plant (FSTP) of 3 KLD (kilolitres per day) capacity was constructed across an area of 1.92 acres in Benipur Gram Panchayat (GP) of Amethi district in Uttar Pradesh under the Swachh Bharat Mission Grameen (SBM-G) campaign. The plant which services a cluster of 11 GPs and one Nagar Panchayat, and caters to a population of 6,30,503 individuals, has been operational since 2021.

The 11 GPs in the cluster are Jangal Ramnagar, Jangal Tikri, Tikariya, Saraikhema, Mehmudpur, Parsawa, Kharauna, Thaura, Sarwanpur, Raibha, and Benipur. Until now, 752500 litres of faecal sludge have been brought to the facility for treatment by desludging tankers 156 times.

From the date of signing of the MoU, the responsibility of O&M has been taken over by the respective Panchayats. The main stakeholders for O&M currently are the District Panchayat Raj Officer, Amethi, and the 11 Gram Panchayats.

Swachhata Se Samridhhi underway in Bihar

With a view to enhancing public participation and community awareness; expediting user charge collection, and quality ODF Plus service delivery, a three-month-long behaviour change communication (BCC) campaign titled Swachhata Se Samriddhi (cleanliness to prosperity) has been rolled out in Bihar.

The focus of the campaign being held between April and June 2023 is on clearing legacy waste and plastic waste in all Ganga Grams and Gram Panchayats of all districts. In this regard, cleanliness drives are being carried out, covering water bodies, Ganga ghats and other public spaces.

Under the campaign, 10 days (15th to 24th of each month) during the months of April to June 2023 are being dedicated to the sanitation and hygiene awareness campaign across the state. The first leg of the campaign was successfully completed between the 15th and 24th of April 2023.

The state has enlisted the support of swachhata supervisors, sanitation workers, Swachhagrahis, Self Help Group (Jeevika didis) members, frontline workers, community influencers and other stakeholders to be engaged in various community awareness activities.

A voice from the state

Kerala has taken a great leap towards achieving the goal of a zero-waste state by adopting a digital solution to waste management. This is in keeping with our efforts to make waste management more efficient which includes enhancing the efficiency of door-to-door collection service through Haritha Karma Sena (Green Task Force) and allied services.

Haritha Keralam Mission, along with the Suchitwa Mission, last year launched a smart garbage monitoring system named Haritha Mithram Smart Garbage Monitoring System App. The App helps to streamline the activities of Haritha Karma Sena and its waste management interventions through time-to-time monitoring of various functional aspects covering the volume of generation from each waste source, its collection, transportation, and various other enormous processes that follow.

The App enables the public to directly participate in the process through a special module incorporated in the App and thereby creates a platform for the Local Self Government Institutions (LSGI) to identify the area of improvisation in waste management allied services.



GWM in Punjab's Sultanpur has enhanced cleanliness, improved health

Greywater management (GWM) is a crucial aspect of sustainable water management practices, especially in rural areas. Sultanpur village in the Malerkotla district of Punjab has taken an effective step towards grey water management that has contributed to beautifying the village, improving the health of its residents, and increasing the capacity of the pond.

The construction of the waste stabilization pond was completed in 2020 by availing INR 11.95 lakh funds under SBM-G.

Sultanpur is spread across 261 hectares and has a population of 1141 individuals from 230 households, the main occupation being agriculture. Having been declared ODF in 2017, the village has been sustaining its ODF status and is now focusing on solid and liquid waste management in keeping with Phase II of SBM-G.

One of the main challenges in the village was the 2-acre filthy pond that emitted bad odour and posed health risks to the community. With the support of the district administration, a comprehensive action plan was framed.

Jharkhand to ensure all its villages are ODF Plus by Dec 2023

The Department of Drinking Water and Sanitation in Jharkhand had a meeting on 9th May 2023 to review the progress of the Swachh Bharat Mission Grameen (SBM-G) campaign and to ascertain what needed to be done to ensure that all its villages declare themselves as ODF Plus by December 2023.

Jharkhand comprises 24 districts which are divided into 5 Commisionaries or Administrative Divisions namely South Chotanagpur, North Chotanagpur, Kolhan, Palamu and Santhal Pargana.

The review meeting for the Kolhan Commisionary held on 9th May at the Auto Cluster-Adityapur was chaired by the Secretary, DDWS - Jharkhand, Dr. Manish Ranjan and was attended by Dr. Neha Arora (IAS) - Additional Secretary-Cum-Director of SBM-G Jharkhand and all Executive Engineers, the Member Secretary of Drinking Water and Sanitation Committee - West Singhbhum, East

Singhbhum and Seraikela-Kharsawan and his team of Assistant Engineers, Junior Engineers, all District Coordinators of JJM and SBM-G, contractors, ISAs partners, and others.

State visits





Jammu and Kashmir: Secretary-DDWS, visited Jammu on 23rd and 24th April 2023 to review the implementation of SBM-G and JJM in the UT and understand the various challenges. She also visited village Dhok Waziran in Nagrota Block which is in the ODF plus Aspiring category, and inaugurated the newly constructed waste collection centre where a baling machine was installed. At the community meeting that followed, around 200 men, women and children were present.

Secretary-DDWS also visited village Chak Lalu Shah in Surey-Chak Gram Panchayat, Block Mandal Phallian which is a model ODF Plus village where she saw the 45 cum Community Bio Gas Plant and interacted with implementing agency (SWAHA) team members to understand the process and O&M plan. The state-level review meeting that followed was also attended by Shri Jitendra Srivastava, Joint Secretary and National Mission Director, SBM-G.



Assam: Union Minister, Jal Shakti chaired a meeting to review the progress of JJM and SBM-G in all the North East States, on May 1, 2023. Present at the meeting were Shri Kailash Baytu, Union Minister of State for Agriculture and Farmers' Welfare, and Sh. Jayanta Malla, Minister, PHED, Government of Assam. The best performing 2 Districts under Swachh Bharat Mission Grameen, based on half-yearly performance from 01/10/22 to 31/03/23 were felicitated. Present at the meeting were Smt. Vini Mahajan, Secretary-DDWS; Shri Jitendra Srivastava, JS&MD, and senior officers from Assam. A booklet named 'Best Practices of SBM-G Assam' was released during the meeting.

On 1st May – JS&MD visited a Plastic Waste Management Unit, a village-level solid waste management facility, and soak pits that were constructed for Greywater Management in Chhaygaon Block of Guwahati District in Assam.





Manipur: On 2nd May 2023, Secretary DDWS visited Yarou Bamdiar Village in Imphal West District, in Manipur to see the progress of work done under Jal Jeevan Mission and SBM-G. She also visited the villages of Kontha Ahallup and Tharoijam.

Meghalaya: JS&MD also visited the community storage shed and household-level greywater management arrangements in Mawdiangdiang and Umroh villages in East Khasi district to assess ODF Plus achievements in rural Meghalaya.

Bihar: Secretary-DDWS along with Shri Jitendra Srivastava (JS&MD) visited Patna, Bihar on 5th May. They met with Shri Bala Murugan D., Secretary RDD, Shri Rahul Kumar Mission Director, SBM-G Bihar; and Chief Secretary Shri Amir Subhani. They interacted with swachhata karmis engaged in waste collection and processing and saw the Waste Processing Unit (WPU) in Sikandarpur village. They also looked at the Plastic Waste Management Unit in Bihta Block and the Amrit Sarovar maintained under MGNREGA and also the Solid Waste Management unit. The Secretary planted a tree along with the Joint Secretary cum Mission Director and other State Officials in Purshottampur Painathi village, Bihta.



Odisha: On her day-2 visit to Odisha on 19th and 20th May, Secretary-DDWS visited Sasan Ambagam, Badiambagam, and Sindurapalli villages in Ganjam district along with Sh. B. Parameswaran, Director-cum-Additional Secretary, DW&S, Department.


